### **CALL TO ORDER:**

Commissioner Kittleman called the meeting to order welcomed the committee members and guests to explain the purpose of the meeting to receive comments and thoughts from the public. Chair Quinn emphasized that the comments shared should cover the three methodologies to be endorsed, AWP, usual and customary and NADAC as the committee looks for a solution for a prescription fee guide.

**Approval of Minutes**: MFG Chair Kittleman and the committee reviewed the September 21, 2023, minutes for approval. Carmine D'Alessandro moved to approve minutes; second by Dr. Jerome Reichmister.

Comments were received from attorneys and pharmaceutical companies. People commented in favor of different methodologies including AWP vs. NADAC.

AWP, average wholesale price is accessible to all stakeholders, covering all medications and is adopted in most states.

Disadvantages of AWP, there's a vast discrepancy of two identical prescriptions 2 by different manufacturers. For example, NDC 71921 10 pills 150mg \$0.59 per capsule and NDC 31722 \$5.80 per capsule.

NADAC, National Average Drug Acquisition Cost developed for Medicaid, a single payer system and does not cover some medications dispensed in workers' compensation claims.

The consensus of the comments is that most presenters favored AWP vs. NADAC.

Comments of the difficulty faced by injured workers obtaining their prescriptions were shared by Yvette Cade and retired Baltimore City police officer Daryl Buhrman.

The public comment of the MFG prescription meeting concluded at 2:26pm with MFG Chair Kittleman discussing scheduling an in-person and virtual meeting as soon as possible to accommodate members and guests from out of town.
